NOTIFICATION

In partial modification of Punjab Government Notification No.13/60/08-ITE2/3795 dated 27.08.2008, the Governor of Punjab is pleased to amend the fees waiver scheme as per given below:-

1. That these seats shall be over and above the sanctioned intake.
2. That this scheme will be implemented by all Government, Government Promoted, Private Aided and Private un-aided Institutions with a permission to fill 10% of total seats filled during the preceding academic year.
3. That only Residents of Punjab (In terms of Punjab Government Department of Personnel & Administrative Reforms (PP II Branch) letter No. 1/3/95-3PP II/9619 dated 6<sup>th</sup> June 1996) will be eligible for admission under this scheme.
4. That the admission will be carried out as per the AICTE policy guidelines by Punjab Technical University, Jalandhar/Punjab State Board of Technical Education & Industrial Training, Chandigarh after the regular counseling and the students already admitted through regular counseling will also be eligible to apply for fee waiver seats subject to fulfillment of other eligibility conditions.
5. The students already admitted in the institutions will be eligible to apply to Punjab Technical University, Jalandhar/Punjab State Board of Technical Education & Industrial Training, Chandigarh for taking admission under fee waiver category. However they will be eligible only for the seats available in their respective institutions. In this way the students already admitted will not be able to change the institution but they will have an opportunity to have a fee waiver seats in the same institution and he shall be able to change branch/trade with in the same institution provided a free seat is available in that trade/branch.
6. It will be the responsibility of concerned institution to refund the fee of such candidates if they get admission in fee waiver quota. Punjab Technical University, Jalandhar/ Punjab State Board of Technical Education & Industrial Training, Chandigarh will make the candidates aware of this scheme through open advertisement.
7. That Punjab Technical University, Jalandhar/Punjab State Board of Technical Education & Industrial Training, Chandigarh will invite online application through separate form and counseling will be carried out manually.
8. That these 10% additional Seats shall be given to the following categories in the ratio mentioned against each.

A)	Women Candidates	50%
B)	Economically Weaker	33%
C)	Physically Handicapped	17%

(For every group of 60 sanctioned intake, 06 additional seats will be given, which will be allocated in the ratio of 3:2:1 for the above categories. In the event of non availability of students in a specific category as above, the benefit will be given to any other candidate of other categories according to merit).

9. Children of parents having annual income of less than Rs. 2.50 lakhs from all sources shall only be eligible for seats under this scheme.

- That the fee including Tuition fee, Institutional charges and University funds for these students shall be completely waived off. Further, the students admitted under this scheme will also be provided free boarding & lodging or transportation subject to availability or provision of funding from Government/Individual or NGO.
  11. That the amount of fee and other charges thus waived off will not be claimed by any institution from the Government or any other authority in any context.
  12. The tuition fee waiver to a student shall be for the complete duration of the course.
  13. The student availing fee waiver seat will not be entitled to avail financial assistance under any other Government scheme what so ever. However he/she shall be eligible for any scholarship available on competition basis.
  14. That the institutions will have to publish in their brochure and website the number of fee waivers available in each category (Woman, economically weaker and physically handicapped) of students in each discipline.
  15. That the institutions shall have to display Fee Waiver status branch wise, to the candidates during the counselling, during admission and at the end of admission process so that the students can freely exercise their choice.
  16. The institutions shall provide the following information to the AICTE, concerned State Govt. and affiliating University/ Punjab State Board of Technical Education & Industrial Training, Chandigarh:-

1. Particulars of each beneficiary including name and rank of the students who have been granted fee waiver, etc. in each discipline/branch of study, and
2. Details of the students admitted against the additional seats including name and rank etc., according to merit prescribed for regular admission.

The institutions shall also display such information in their websites for information to the students and other stake holders.
