# GOVERNMENT OF PUNJAB DEPARTMENT OF TECHNICAL EDUCATION AND INDUSTRIAL TRAINING (TECHNICAL EDUCATION BRANCH-II) NOTIFICATION

The Governor of Punjab is pleased to appoint the Punjab State Board of Technical Education and Industrial Training, Chandigarh (hereinafter the Board) as the authority competent to make admission to Part Time Diploma (LEET) Courses for the academic session 2021-22. The Board shall recommend and authorize admission to the Part Time Diploma (LEET) Course being run in the various Polytechnics/Institutions located in the State of Punjab affiliated with the Board and stand approved by the All India Council for Technical Education for the session 2021-22.

Lateral Entry Admission to 2<sup>nd</sup> year of Four Year Part Time Diploma Courses (Civil Engineering, Mechanical Engineering, Electrical Engineering)

## A. <u>ELIGIBILITY CRITERIA FOR THE ADMISSION (BASIC EDUCATIONAL QUALIFICATION)</u>

I. Passed 10+2 Examination with Physics/ Mathematics/
Chemistry/ Computer Science/ Electronics/ Information Technology/
Biology/ Informatics Practices/ Biotechnology/ Technical Vocational
subject/ Agriculture/ Engineering Graphics/ Business Studies/
Entrepreneurship (Any of the three)

OR

10<sup>th</sup>+(2 years ITI) with appropriate trade

In that order shall be eligible for admission to second year Diploma course(s) of appropriate program, up to a maximum of 10% of sanctioned intake plus the unfilled vacancies of the First Year.

Vacant seats arising out of the students withdrawing the admission in the First Year shall also be considered for Lateral Entry.

- II. In case the seats remaining unfilled on the basis of criteria mentioned above shall be made on the basis of inter-se-merit of any of the following examination
- a. 10+2 Vocational examination in various branches from a board recognized or established by Central /State Government through a legislation.
- b. Two year Certificate Courses from Sant Longowal Institute of Engineering and



Technology, Longowal

- c. Two year certificate course in Skilled Technician (Mechanist), Skilled Technician (Machine Maintenance) & Quality Assurance inspector form R&D Centre for Bicycle and Sewing Machine Ludhiana.
- III. Part time Diploma (LEET) level course is only for working professionals with at least minimum of two year full time experience in registered firm/company/industry/educational and/Government/ autonomous organization in the relevant field in which admission is sought.
- Part time diploma course is only for working professionals.
- V. Part time Diploma (LEET) level shall be conducted in evening time i.e. 5.30 PM to 9.30 PM (Six days a week) and its Duration shall be of 3 years.
- VI. For the Academic session 2021-22, 85% seats shall be reserved for the candidates from within the State of Punjab and 15% shall be open to the candidates from outside Punjab on All India basis.
- VII. The Eligibility criteria for 85% seats will be that candidate shall be a resident of Punjab States per Punjab Government, Department of Personnel and Administrative Reforms (PP-II Branch) letter No. 1/3/95-3PPII/9619 dated 6<sup>th</sup> June 1996 and letter No. 1/3/95-3PPII /80 dated 1<sup>st</sup> January, 1999 or shall have passed examination mentioned at Sr. No. I and II from an institution/school situated in Punjab. The candidate would be required to submit a certificate to this effect from the Principal/Head of Institution last attended in the prescribed Performa as given in the prospectus.
- VIII. Apart from the basic educational qualifications prescribed above, the general eligibility criteria shall be as mentioned in Punjab Government, Department of Technical Education and Industrial Training Memo. No. 35/44/95-1T(2)/978 dated 21st March, 2003.
- IX. The State Board of Technical Education and Industrial Training, Punjab shall formulate a scheme for making admissions.
- X. The students shall pay the fees/ development fee and other charges both for the various seats, as per rates fixed by the Government of Punjab or the Board.
- XI. The fee structure for Foreign Nationals/PIO shall be the same



as is in vogue for NRI candidates.

XII. The guidelines for admission of Kashmiri migrants shall be as per Punjab Government in this regard. (Memo No. 8/21/11-ITE2/501423/1 dated 05.06.2015)

XIII. The guidelines for admission of Foreign Nationals/ Persons of Indian Origin shall be as per Punjab Government Notification No. 13/75/2001-ITE2/296 dated Chandigarh the 23<sup>rd</sup> January, 2003.

XIV. The management quota shall be as per Punjab Govt. Departments of Technical Education and Industrial Training Memo No.13/129/2003-1TE2/1247 dated 25<sup>th</sup> April 2008, No.13/129/2003-1TE2/1892 dated 20<sup>th</sup> June 2008 and No.13/129/03-1TE2/171 dt.17<sup>th</sup> January 2011as amended from time to time.

XV. There shall be no bifurcation of the seats into "free seats" and "paid seats" This is in compliance with the judgment of the Honorable Supreme Court of India vide its judgment the case of T.M.A. Pai Foundation and other vs. State of Karnataka and others (2002) (8 SCC 481: AIR 2004 SC 355), and the instructions of Government of India, Ministry of Human Resource Development and the AICTE.

XVI. Admission of candidates, who fulfill all eligibility conditions, shall be made on the basis of the relative merit subject to reservation of seats, the detailed instructions in respect of which are given in Section B.

XVII. Academic session for newly admitted students may commence as per the academic schedule of AICTE for AY 2021-22.

XVIII. State Government reserves its right to change any condition at any point of time.

#### B. RESERVATION:

I. The reservation of seats shall be as per Punjab Government, Department of Technical Education and Industrial Training Memo. No. 13/2/05-1TE2/1987 dated 2<sup>nd</sup> July, 2013 and Memo No. 8/41/2019-4TE2/53 dated 13<sup>th</sup> Sep, 2019. As regards the reservation of seats of Chandigarh Polytechnics, the same shall be as per the



policy intimated by the Chandigarh Administration to the Board.

- II. The attention of the applicants desirous of claiming reservation under any category whatsoever is especially drawn to the condition and stipulation that only the certificates that have been issued on or before the last date of counselling shall only be accepted. The candidates are accordingly advised, in their own interest, to get the requisite certificates issued well before the cut-off date, otherwise their certificates shall not be considered and their claim for reservation shall be summarily rejected. No extension shall be granted in this regard, under any circumstances. This provision should be given wide publicity and also included conspicuously in the prospectus-cum-information brochure to be issued by the Board.
- III. The Board shall make a provision in the Online Admission application form for the candidates to indicate the category, if any, under which they are seeking reservation. In case of no reservation is claimed in the application form, candidate shall be treated as general category. The Government of Punjab may also set up a Committee to effect inter se gradation of candidates claiming reservation under certain categories, as indicated in the aforesaid memo dated 2<sup>nd</sup> July, 2013. In the absence of this Committee, the Board shall effect this inter se gradation, in accordance with the criteria laid down in the aforesaid memo dated 2<sup>nd</sup> July, 2013.
- IV. A candidate shall be eligible to make claim for reservation under one reserved category only. However, the procedure for counselling/allotment of courses and/ or institutes shall be such that if a candidate is getting a course/ institution higher in his/her order of preference, as a general candidate, he/ she shall be so regarded, notwithstanding his/her claim as a reserved category candidate. The seat under the reserved category shall then be offered to the candidates in that very reserved category.
- V. The unfilled seat in any reserved category shall be merged in the General Category quota after all eligible candidates of the reserved categories have been called for counselling.

#### C. ONLINE- COUNSELLING

I. For admission to Part Time Diploma (LEET) Courses web based online counseling shall be followed for the Academic year



2021-22 and therefore physical presence of candidates for the counseling will not be necessary.

- II. During the online counseling, candidate shall be given opportunity to exercise choice of institutes / trade in centralized counseling and thereafter the vacant seats, if any, shall be filled by the institute on the criteria of admissions under management quota. It is categorically laid down that vacant seats are not being transferred as management quota seats. Only criteria as laid down for admission under management quota should remain applicable to fill such vacant seats.
- III. The Board shall give a public notice in leading newspapers regarding the schedule of counselling.
- IV. While fixing the date of counselling for admissions, the Board shall keep in view the cut off date and schedule for approval by All India Council for Technical Education for the academic session 2020-2021.
- v. There shall be two rounds of centralized counselling by State Board of Technical Education, Punjab Chandigarh. The schedule and Deadline of Counseling will be as per Academic Calendar issued by AICTE in July, 2021 for the academic session 2021-22 and strictly as per orders of honorable Supreme Court.

#### D. ADMISSION SCHEDULE

The last date, up to which students can be admitted against vacancies will be as per academic calendar issued by AICTE in July 2021 for the academic session 2021-22 and strictly as per the orders of Honorable Supreme Court.

### E. OVER-RIDING PROVISION:

- I. Nothing in this notification shall be operative in so far as it is inconsistent with the law of the land as laid down of the judgment of the Honorable Supreme Court of India in the case of T.M.A. Pai Foundation and other vs. State of Karnataka and others (2002) (8 SCC 481: AIR 2004 SC 355) or any other order of any Honorable Court. Any such inconsistency may be brought to the notice of the Government of Punjab, clearly highlighting the inconsistency, for immediate rectification.
- II. The institutions which do not make admission on the Central



Admission procedure as notified by the Board, from time to time or violate any of the above terms and conditions, shall automatically stand disaffiliated from the Board without any further notice.

III. The notifications, circulars and instructions of the Government of Punjab as referred to in A-VII,A-VIII,A-XIII,A-XIV,A-XV,B-I,D-I and E-I in this notification shall be treated as part of this notification for all purposes and all the provisions of this notification shall be read along with the contents of said notification/circulars and instructions.
