- c) Two years certificate course in skill Technician (Machinist), Skill Technician (Machine Maintenance) & Quality Assurance Inspector from R&D Centre for Bicycle & Sewing Machine, Ludhiana.
- d) 3 Years AICTE approved Diploma in Engineering of any other branch from any recognized Board (As per Punjab Govt notification No TECH-TE-2013/5/2021-4TE2/1061 dated 28-10-2021)

Should be read as under:

10th along with 2 years ITI shall be eligible for admission to Second Year Diploma Courses of in any branch of Engineering and Technology The intake of an institute shall be as per AICTE guidelines.


