AN
ORDINANCE

further to amend the Punjab State Board of Technical Education and Industrial Training Act, 1992.

Promulgated by the Governor of Punjab in the Sixty-third Year of the Republic of India.

Whereas the Legislative Assembly of the State of Punjab is not in session and the Governor is satisfied that circumstances exist which render it necessary for him to take immediate action.

Now, therefore, in exercise of the powers conferred by clause (1) of article 213 of the Constitution of India, the Governor of Punjab is pleased to promulgated the following Ordinance, namely:--

1. (1) This Ordinance may be called the Punjab State Board of Technical Education and Industrial Training (Amendment) Ordinance, 2012.

Short title and commencement.

- (2) It shall come into force at once.
- 2. In the Punjab State Board of Technical Education and Industrial Training Act, 1992, for the long title, the following long title shall be substituted, namely:-

"to provide for the establishment of a State Board of Technical Education and Industrial Training for promotion and co-ordination of technical education and industrial training in the polytechnics and industrial training institutes in the

(Punjab Act No. 17 of 2013)

further to amend the Punjab State Board of Technical Education and Industrial Training Act, 1922.

BE it enacted by the Legislature of the State of Punjab in the Sixty-third Year of the Republic of India as follows:—

1. (1) This Act may be called the Punjab State Board of Technical Education and Industrial Training (Amendment) Act, 2012.

Short title and commencement.

- (2) It shall be deemed to have come into force on and with effect from the 31st day of October, 2012.
- 2. In the Punjab State Board of Technical Education and Industrial Training Act, 1992 (hereinafter referred to as the principal Act), for the long title, the following long title shall be substituted, namely:—

Amendment in the long title of Punjab Act 2 of 1993:

"to provide for the establishment of a State Board of Technical Education and Industrial Training for promotion and co-ordination of technical education and industrial training in the polytechnics and industrial training institutes in the State of Punjab and for subjects connected therewith including those under the Skill Development Initiative (SDI) Scheme or any such other Scheme."

3. (1) The Punjab State Board of Technical Education and Industrial Training (Amendment) Ordinance, 2012 (Punjab Ordinance No. 8 of 2012), is hereby repealed.

(2) Notwithstanding such repeal, anything done or any action taken under the principal Act, as amended by the Ordinance referred to in sub-section (1), shall be deemed to have been done or taken under the principal Act, as amended by this Act.

- In the Punjab State Board of Technical Education and Industrial Amendment in Training Act, 1992, in section 21, in sub-section (2), for the words "sixty two years", the words "seventy years" shall be substituted.
