With reference to this office letter of even no. dated 08.12.2017 on the subject cited above, it is to inform that the proposed second round of 106<sup>th</sup> AITT under ATS online exam for theoretical papers i.e. Theory, W/Sh. Calculation & Science and Employability Skills is scheduled to be held from 20.02.2018 to 22.02.2018 by the agency selected for this purpose by DGT for the left out candidates and who have failed in the first round of 106<sup>th</sup> AITT under ATS online exam of theoretical paper conducted from 28.11.2017 to 30.11.2017.

The second round of 106<sup>th</sup> AITT under ATS online exam is schedule as below:-

The hall tickets for appearing in 106<sup>th</sup> AITT under ATS online exam for theoretical paper is available in online exam portal i.e. <http://dgt.cbtextam.in> from 14.02.2018 onwards and will be issued by concerned establishment. However, individual apprentices can also download the hall ticket from this online exam portal.

The hall ticket for online examination papers of the candidates whose records are not available on the apprenticeship portal must be attested by the concerned apprenticeship advisor who has approved the contract. **Attestation must have name of Official, Seal and Signature with Date.** No examinee will be allowed to enter the examination hall without a valid hall ticket. Examinee must also carry a valid photo ID card preferably issued by a Govt. agency. **Hall tickets generation from any other sources will not be acceptable for online exam.**

**The exam of theoretical subject (Trade Theory, Employability Skills and W/sh. Calculation & Science) will be conducted online with MCQs and the trainee has to attend this exam on computer at examination centre provided by the agency selected by DGT.**

The State Apprenticeship Advisor / Regional Directors of Apprenticeship Training are requested to depute atleast one official at each exam centres as Observer during online examination.
