Sir/Madam.

The DGT ecosystem is undergoing reforms process in examination/ assessment and certification. In this process the mode of examination has been shifted to Computer Based Test (CBT) for theoretical portion of examination completely

The matter of conducting supplementary examination for ex-failed trainees of erstwhile semester pattern trainees have been deliberated at length. It has been approved by the competent authority that such trainees shall be given one last chance to appear their theoretical exams in Optical Marks Reader (OMR) pattern. After this examination, for the trainees who still need to appear in further supplementary examinations, the system of examination pattern shall be converted to the CBT mode. The trainees shall be advised to take a note of above and DGT shall not entertain any further OMR based examination for these trainees accordingly.

In this connection, the AITT under CTS (Semester System i.e. Trainee admitted on or before Academic Session 2017) and Dual System of Training (Trainee admitted on or before Academic Session 2017) is proposed to be held from 04-Oct-2021 to 07-Oct-2021 (Date sheet enclosed). You are requested to complete the above activities well within the specified period, so that Hall Tickets can be processed on NCVT MIS Portal.

Further, Few SPIUs has already created center mapping for theoretical subjects in Feb 2020 . For such cases SPIU is required to share the correct exam centre mapping with DGT (Previous mapping will be shared to S/D shortly).

In view of above, you are requested to strictly adhere to the specified dates and also ensure entry of eligibility criteria sessional marks, on fees and attendance by the concerned ITIs under your control, so that hall tickets can be downloaded by trainees well in advance before commencement of AITT.

Further, it is informed that the trainees are being given this last chance to appear in OMR mode of examination for Semester System (<u>Trainee admitted on or before Academic Session 2017</u>) only. Thereafter, DGT will shift to CBT mode of examination for Semester System trainees i.e. those who were admitted on or before 2017 academic session also.

NOTE: - Trainees without NCVT MIS generated Hall Ticket shall not be allowed to appear in exam.

* Hall tickets of only Theory subjects will be available for downloading. Practical /ED examination has already been conducted in Nov/ Dec 2020 and Feb, 2021.
