This is regarding changing of nomenclature of 'Carpenter' trade to 'Wood Work Technician'.

As you are aware, under the Craftsmen Training Scheme (CTS), vocational training is being offered in 152 NSQF compliant courses. These NSQF compliant courses are revised based on feedback from industries, academia States / UTs and another stakeholders. The syllabus of the course (Carpenter) has also been restructured and rationalised in the year 2022-23 using the latest technology and teaching techniques. It has also been decided with the approval of the Competent Authority to rename the trade called 'Carpenter' to 'Wood Work Technician'. The Nomenclature 'Wood Work Technician' will be applicable with effect from the session 2023-24. The curriculum for the trade will be uploaded on the DGT website at link https://dgt.gov.in/cts_details alongwith details shortly.

From the session 2023 onwards, the new admission will be only under the trade name 'Wood Work Technician' and admission under the name 'Carpenter' will not be taken from session 2023-24 onwards.
