
Subject: Conduct of All India Trade Test (AITT) for odd and even semester separately.

Sir,

This is to inform you that AITT on semester pattern is being conducted by DGE&T in month of July/ August and January/ February of every year. In this regard, it is intimated that hence forth, the AITT for odd semester i.e. first & third shall be conducted in the month of January/ February of every year. Similarly, AITT for even semester i.e. second and fourth shall be conducted in the month of July/ August of every year.

Accordingly, failed candidate in first or third semester would appear after one year when the AITT of first and third semester are conducted under CTS. Similarly, if the candidate failed in the second or fourth Semester would appear after one year when the AITT of second and fourth semester are conducted under CTS.

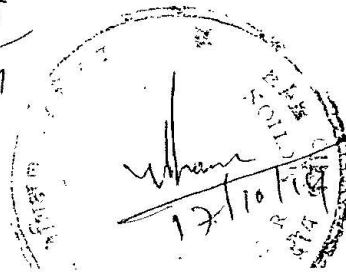
