Subject:- Conduct of annual exams for the trainees admitted in ITIs from the session August, 2018 onwards for AITT under CTS- regarding.

Sir,

In response to various suggestions received from State Directorates, ITI trainees & ITIs' management and after consultation with various Stake holders, the competent authority has approved following for implementation with immediate effect:-

- (i) The trainees admitted upto admission session august, 2017 will continue with the semester system exam till all chances available to trainees as per rule are availed by them i.e. upto August, 2021. Total five (one regular and 4 additional) chances are given for clearing the examination for each semester.
- (ii) Annual exams will be conducted for the trainees admitted from the session August, 2018 and their first annual exam has to be conducted in the month of July/August, 2019 after completing the training as per syllabus of both Semester-I & II combined. Similarly, second annual exam has to be conducted in the month of July/August, 2020 after completing the training as per syllabus of both Semester-III & IV combined. Trainees of 2 years duration trades will attempt 02 annual exams i.e. one for each year of training and could avail total 5 chances for clearing each annual exam (one regular and 4 additional attempts).
- (iii) A parallel MIS module will be developed in NCVT MIS Portal with the facility for annual exams to avoid any operational issues with present semester system module which is going to be phased out in 2021.
- (iv) The pattern of e-marksheets & e-NTC will remain same as semester exam and will be issued through NCVT MIS Portal for annual system i.e. one marksheet for each annual exam and consolidated marksheet will be issued after completion of the course.
- (v) The marking scheme for the subjects and total marks will be in line with previous conventional examination system running before admission session August, 2013.
- (vi) Grace marks in annual exam will be 7 marks for engineering trades & 2 marks for non-engineering trades as followed in semester system.

- (vii) In annual examination system the pass marks for theoretical subjects will be 40%, Employability Skill 35% and for Practical 60%. Format of marksheets is enclosed for ready reference.
- (viii) Internal monthly assessment of trainees should be done by ITI concern in practical and theoretical subjects to ensure progressive learning and awarding sessional marks accordingly.
- (ix) In case of private candidates there will not be any sessional marks.
- (x) Final examination for a year of training will be held in July/August and supplementary exam for ex-failed trainees in January/February every year.
