INSTRUCTIONS FOR PRIVATE CANDIDATES AND FOR THE HEAD OF INDUSTRIAL TRAINING INSTITUTE/CENTRES REGARDING FILLING THE APPLICATION FORM OF THE PRIVATE CANDIDATES UNDER CRAFTSMEN TRAINING SCHEME (SEMESTER SYSTEM PATTERN).

1. ELIGIBILITY

- i) The candidates who are working in establishments implementing Apprenticeship Training Programme are allowed to appear in the All India Trade Test (under new Semester System Pattern)under Craftsmen Training Scheme as private candidates. However, candidates of the establishments/Govt.Deptt./ undertaking whose main plant/office(may be located elsewhere) are implementing the aforesaid scheme may also appear as Private Candidates provided they are officially sponsored.
- ii) The candidates having 3 years Industrial/teaching experience working in ITIs are allowed to appear as private candidates in the relevant /allied/similar trade under Craftsmen Training Scheme.
- iii) The applicants who possess a minimum of 3 years Industrial/teaching experience as a regular staff on full time basis in the relevant trade would be considered eligible for appearing in the All India Trade Test under Craftsmen Training Scheme as private candidates.
- iv) No relaxation is admissible in the minimum prescribed qualifications for a particular trade for appearing as private candidate (academic qualification should be according to DGE&T Norms).

2. GENERAL INFORMATION

- i) The application form complete in all respect should be submitted in duplicate alongwith proof of educational qualifications: Fee of Rs. 300/- (Cost of Form Rs. 100/- + Processing Fee Rs. 200/- and annexure I, II and III to the head of the Institute/Centre concerned and the Institute/Centre will send the original copy of the application form to the Board scrutiny of the application.
- ii) All candidates whose name appear in the list of successful candidates (to be uploaded on website of the Board) after final scrutiny will have to deposit registration form fee Rs. 50/-, Registration fee Rs. 100/-, examination fee Rs. 500/- and Practical fee Rs. 50/- (total Rs. 700/-) in the form of draft payable to the Secretary, Punjab State Board of Technical Education & Industrial Training, Chandigarh.
- iii) The break in experience of a particular trade for over two years from the last date of submission of application will not make a person eligible unless 3 years experience has been put in subsequently in the trade in which he wishes to be trade tested.
- iv) The candidate should seek information with regard to date-sheet, Centre and Roll No. from the concerned Institution/Centre. In the event of any candidate approaching the Board directly/ indirectly, his application is liable to be cancelled/rejected.
- v) The Secretary of Punjab State Board of Technical Education and Industrial Training, Chandigarh is not bound to intimate the reasons of rejection of eligibility. All information regarding eligible candidate will be sent to the concerned institute/centre before the start of examinations
- vi) Last date of submission of application form by the candidate to the concerned Institute/Centre is 03.11.2014.
- vii) Last date of submission of applications by the concerned Institute/Centre to Board is 18.11.2014.
- viii) These application forms should be routed through the Principal-cum-Assistant Apprenticeship Advisor under whom the experience has been acquired.
- ix) For information on detailed syllabus, Head of the Institute/centre may be contacted.
- x) Furnishing false information shall render liable to be penalised under Factory Act.
- xi) Every Application form must be verified by the Principal-cum-Assistant Apprenticeship Advisor of the Institute.
- xii) Experience Certificate should be obtained from the employer/competent authority in prescribed format for Experience-cum-Eligibility Certificate (annexure-I). Any deviation from the prescribed format may straightway lead to rejection of the application.
