**Subject: Examination for the CTS Trainees admitted from August 2014 Session – Postponement of Practical Examination -- reg.**

Sir,

As you are aware that DGE&T has developed NCVT-MIS portal ([www.ncvtmis.gov.in](http://www.ncvtmis.gov.in)) to streamline the functioning of ITIs, CFIs, Apprenticeship Scheme and assessment/certification of all NCVT training process wherein certificates (for trainees admitted from August 2014 session) will be issued as e-certificates from the portal drastically reducing the turnaround time for trainees receiving the certificate. MIS portal will be a single window self-service platform delivering services to current and prospective trainees, employers / establishments, ITIs, State Directorates and DGET.


It was conveyed vide our letter dated 21<sup>st</sup> July 2014 that all admission records for August 2014 session need to be uploaded by the State Directorate to the MIS portal developed by DGE&T. Subsequently, a workshop of the State officers was also held during August / September 2014 wherein interalia, the requirements of data upload for the ITI Affiliations and trainees admitted for the August 2014 session was conveyed. The formats were provided to the States and were requested to send ITI Affiliation data along with Trainees data to this Directorate immediately. However, there have been delays in receiving the Data which also went under correction no. of times to be suitable for uploading on MIS portal. It is informed that momentum of receiving the data picked in January 2015 and with the full cooperation of States, data of approx. 7.3 Lakh trainees of August 2014 are available in the aforesaid portal. It is also informed that till date some of the States are still correcting the data and therefore data of trainees of such States could not be uploaded so far. In order to speed up the process of issue of hall tickets from the Portal, DGE&T decided to upload the Trainee Data itself on the portal instead of the States.

The above exercise has been very useful in mapping the affiliated trades with the trainees admitted and this will be a valuable asset for improving the system as a large.

Keeping in view that the semester exam for the trainees admitted in 2014 are scheduled for 9<sup>th</sup> February, 2015 and considering that some of the States are yet to compile and provide correct data of affiliated trades along with the trainees admitted for August 2014 session, it has been decided to postpone the Practical examination for Semester –I ( for practical going to be held on 9<sup>th</sup>, 10<sup>th</sup> & 11<sup>th</sup> February, 2015 will now be held on 2<sup>nd</sup>, 3<sup>rd</sup> & 4<sup>th</sup> March, 2015) as per revised enclosed date sheet.

There will be no change in the examination schedule for other trainees. It is again emphasized that the Trainees having hall ticket generated from NCVT MIS Portal with QR code are only eligible to appear in the AITT for trainees admitted in August 2014.




