Subject: Scheme of award of Full Fee Concession to the students of Diploma.

Sir,

The Board is pleased to invite applications for the award of 110 Full Fee Concession for the students admitted in session 2019-2020. The student should have taken admission in Diploma course through online counselling. The conditions for Full fee concession are:

1. The family income of the applicant from all sources should be less than 1,50,000/- per year.
2. The candidates who are already drawing a benefit of scholarship/ fee concession/ benefit in fee under SC category are not eligible for this scheme.
3. If student is drawing benefit under Fee waiver scheme then his case should be sent separately for the exact amount deposited.

Institutes are not required to forward the documents determining eligibility of a student; instead the Head of Institute will furnish below mentioned undertaking: that all the students whose data are forwarded, are eligible for receiving the benefit under each Scheme

In case the number of applicants in respective category is more than the Fee concession available, the applicants shall be selected on the basis of marks secured in 10th class for Diploma students and marks secured in ITI & +2 for LEET, Diploma in Pharmacy, and Diploma in MOP students.

Supporting documents, i.e. self declaration, detail marks, income proofs, certificates etc. should not be sent along with the filled in Performa. The principal shall verify all documents before forwarding the detailed information of the students to the board.
