1. The family income of the applicant from all sources should be less than 1,50,000/- per year.

The candidates who are already drawing a benefit of scholarship/ fee concession/ benefit in fee under SC category are not eligible for this scheme.

 If student is drawing benefit under Fee waiver scheme then his case should be sent separately for the exact amount deposited.
