As per the approval of competent authority, based on the directions received from the Director, Technical Education and Industrial Training Department, (Technical Education Wing) Punjab, Chandigarh vide letter No. DTE-CBONOTI/3/2021-I/446347/2022 and; as per the guidelines of AICTE, New Delhi issued in para 7.10 of the Approval Process Handbook for session 2023-24; this is inform that following institutes are hereby allowed to admit students under four year Part Time Diploma Courses as per the bifurcation of seats mentioned below:

Instructions for Admission to Part Time Diploma Courses (PTD) and PTD through Lateral Entry:-

- 1. The Admission to Part Time Diploma level engineering courses shall be made through Online Counseling.
- The Eligibility for Admission to Part Time Diploma (PTD) courses and PTD through Lateral Entry shall be as per the eligibility criteria mentioned in the Notification of Govt. of Punjab issued for Admission to Regular Diploma Level Courses and Lateral Entry Admissions for session 2023-24 respectively.
- In addition, Part Time Diploma Course is only for working professionals with minimum of two years full time experience in registered firm/ Company/ Industry/ Educational and Government/ Autonomous organization in the relevant field in which admission is sought.
- The duration for PTD courses shall be of four years and PTD (through Lateral Entry) shall be of three years.
- 5. As per the guidelines of AICTE, Courses offered in the timings of Regular Shift, First Shift, Second Shift and Part Time shall be considered as Regular Courses. The Institutions shall have to fulfill all facilities such as Infrastructure, Faculty and other requirements to offer the Regular Courses as per the norms specified in the Approval Process Handbook for the Total Approved Intake and the Institutions may conduct the Courses in the timings of Regular Shift, First Shift, Second Shift and Part Time not exceeding the "Approved Intake" of each Course, as per the convenience of all stakeholders.

6. Institute shall provide the required facility to the students under this type of enrollment. Institute shall maintain the student-faculty ratio.
