Subject: Empanelment and Ranking of Banks for placement of funds by Govt. Departments / Corporations / Boards /LocalBodies / Agencies etc.

In supersession of letter I.D. No. III/I/2019/IF/I/611-827 dated 21/07/2020 issued by the Government of Punjab, Department of Finance, Directorate of Institutional Finance & Banking has empanelled and ranked the following Banks based upon their performance as on 31/03/2022 in the State.

2. A Committee was formed for analysis of the performance of the Banks as per laid down empanelment guidelines/criteria and the data as per 160th SLBC Agenda Booklet has been considered for the same.

3. Regarding the Small Finance Banks (SFBs) which have been empanelled it has been decided that the deposits in these banks will be capped at a maximum of 10% of total deposit amount in each bid. This means, if any of the Small Finance Bank quotes highest rate of interest among all the empanelled banks then only 10% of the total deposit (bidding amount) can be placed with the empanelled SFB and balance 90% of the total deposit amount will be placed with the bidder bank which has quoted 2nd highest rate of interest other than Small Finance Bank. It is further clarified that in case the highest rate of interest has been quoted by the bank other than SFB, then the whole deposit (bidding amount) will be placed with that bank and no part of deposit will be placed with the empanelled SFB.
