Subject: Grant of Financial Assistance to Students hailing from economically weaker sections of the society.

Applications are invited for grant of Financial Assistance, under different Schemes of the Board, to the eligible students admitted in affiliated institutions through Centralized Online Counseling, for 2017-18 batch. Each Scheme has its own eligibility requirements:

A. Award of full fee Concession:

Eligibility Conditions:

1. Combined annual income of the family should not be more than Rs.150, 000.
2. Students should not be the recipient of benefit of financial assistance under any other scheme of the Government/Board.
3. *Student, pass in all the subjects or having reappear in not more than two subjects of first year, will be eligible for benefit in second year. (*Condition is applicable for 3 year diploma courses only)
4. Student must have passed all the subjects of previous year(s) to be eligible for benefit in the final year.

B. Award of Scholarships (@Rs.1000/- per month):

Eligibility Conditions:

1. Benefit will be awarded on Income-cum-Merit basis.
2. Combined annual income of the family should not be more than Rs.2 Lac.
3. Students should not be the recipient of benefit of financial assistance under any other scheme of the Government/Board.
4. *Student, pass in all the subjects or having reappear in not more than two subjects of first year, is eligible for benefit in second year. (*Condition is applicable for 3 year diploma courses only)
5. Student must have passed all the subjects of previous year(s) to be eligible for benefit in the final year.

C. Award of Full Fee Concession/Scholarships under Discretionary Quota of Chairman.

Eligibility is limited to the students/families falling under any of the following categories:

1. Orphans
2. War widows and their wards
3. Have lost the only bread winner of the family
4. Physically handicapped to the extent of 50% and above
5. Students facing extreme circumstances in life making them a fit case for sympathetic consideration.
6. Students should not be the recipient of benefit of financial assistance under any other scheme of the Government/Board.

For schemes at A & B above, the eligibility of beneficiary student will be ascertained at the level of the institute. Institutes are not required to forward the documents determining eligibility of a student; instead the Head of Institute will furnish an undertaking: that all the students whose data are forwarded, are eligible for receiving the benefit under Scheme (name of scheme).

Whereas, in case of scheme at point 'C' above the eligibility will be determined by the board, hence all the original and attested copies of the requisite documents supporting eligibility will be forwarded by institute to the Board.
