
## Admission Notice (Session 2020-21)

DTE-CBONOTI/11/2020-conduct/589 dated 01-07-2020 and letter vide File No. TECH-TE-2010/258/2020-4TE2/I/104855/2020 dated 17/11/2020 issued by Government of Punjab, Department of Technical Education and Industrial Training, (Technical Education-2 Branch) Candidates, who have not passed the ITI examination but are appearing in examination to be held in the month of November-December 2020 shall also be allowed to be admitted provisionally subject to the following conditions-

- 1. All the conditions are same except result of the ITI examination.
- 2. Only those candidates will be provisionally admitted who are appearing in the ITI examination.
- 3. Punjab State Board of Technical Education & Industrial Training will maintain the record of the provisionally admitted students and will convert the provisional admission into the regular admission within 15 days after the declaration of the result for all those who pass the qualifying examination.
- 4. Provisional Admission of the students who fail in the ITI qualifying examination will stand cancelled and their fee will be refunded by the concerned institution/board.

The above concession is given due to present situation of pandemic COVID-19 in the state of Director Academics Punjab and should not be taken as precedence for future.

In partial modification of Punjab Government Notification issued vide Letter no. DTE-CBONOTI/1/2020-CONDUCT/589 Dated 01-07-2020 regarding 2<sup>nd</sup> year diploma level engineering courses under LEET scheme, the Governor of Punjab is pleased to add the following provisions:-

### ELIGIBILITY FOR ADMISSION TO DIPLOMA LEVEL COURSES (LEET SCHEME)
