

 - iv) Services
- d) the other conditions for existing institutions with regard to Pharmacy Education Regulatory Charges, GST submission of statutory documents for introduction of new pharmacy course(s) / raise in admission / services will remain same as mentioned in Council's earlier circular No.14-56/2021-PCI (Approval Process - of 14.12.2021 e.s.), 5669-71 dt.9.12.2021. Please note that this is the last opportunity to the existing institutions and no further extension of date will be done by the Council.
