

**Subject: Conduct of Practical Examination of 3<sup>rd</sup> to 6<sup>th</sup> semester regular and 3<sup>rd</sup> to 8<sup>th</sup> semester Part Time Diploma courses, 1<sup>st</sup> to 4<sup>th</sup> year annual courses and 1<sup>st</sup> & 2<sup>nd</sup> year diploma in Pharmacy-regarding.**

Sir/Madam,

The practical examinations of 3<sup>rd</sup> to 6<sup>th</sup> semester regular and 3<sup>rd</sup> to 8<sup>th</sup> semester Part Time Diploma courses , 1<sup>st</sup> to 4<sup>th</sup> year annual courses and 1<sup>st</sup> & 2<sup>nd</sup> year diploma in Pharmacy pertaining to December 2010 examinations have been scheduled to be held from **25<sup>th</sup> November to 3<sup>rd</sup> December 2011.** In order to reduce the total no. of days required for **Practical Examination by way of making three groups, the practical examination shall be conducted at the level of the institutes. Therefore no external examiners shall be sent to the institutes by the Board for the conduct of practical examinations of 3<sup>rd</sup> to 6<sup>th</sup> semester regular and 3<sup>rd</sup> to 8<sup>th</sup> semester Part Time Diploma courses, 1<sup>st</sup> to 4<sup>th</sup> year annual courses and 1<sup>st</sup> & 2<sup>nd</sup> year diploma in Pharmacy. Consequently the institutes shall conduct the practical examinations of 3<sup>rd</sup> to 6<sup>th</sup> semester regular and 3<sup>rd</sup> to 8<sup>th</sup> semester Part Time Diploma courses, 1<sup>st</sup> to 4<sup>th</sup> year annual courses and 1<sup>st</sup> & 2<sup>nd</sup> year diploma in Pharmacy between 25<sup>th</sup> November to 3<sup>rd</sup> December 2011 with the following guidelines.:**

- a. The institute shall invite external examiners from the nearby colleges / senior secondary schools / polytechnic /industry for the conduct of practical examination.
- b. Depending upon the course and the number of students, two practical examinations can be held for regular students on the same day.
- c. The entire process of practical examination of 3<sup>rd</sup> to 6<sup>th</sup> semester regular and 3<sup>rd</sup> to 8<sup>th</sup> semester Part Time Diploma courses, 1<sup>st</sup> to 4<sup>th</sup> year annual courses and 1<sup>st</sup> & 2<sup>nd</sup> year diploma in Pharmacy shall be conducted between **25<sup>th</sup> November to 3<sup>rd</sup> December 2011.**
- d. The practical awards duly signed by both the external and internal examiners shall be submitted to the Board's office by **9<sup>th</sup> December 2011.**
- e. The awards shall also be submitted online through the Board's website pbtchedonline.com. The detail shall be available on the site in the **2<sup>nd</sup> week of December.**

**The practical answer books shall be available from 10<sup>th</sup> November 2011.**
