The student should have taken admission in Diploma course through online counselling. The conditions for Full Fee Concession are:

- The family income of the applicant from all sources should be less then 1,50,000/- per year.
- 2. The candidates who are already drawing a benefit of scholarship/ fee concession/ benefit in the under SC category are not eligible for this scheme.
- 3. The candidate already drawing benefit under fee waiver scheme are not eligible for this scheme.
