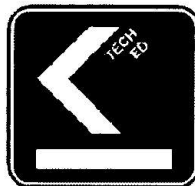

CONDITIONS GOVERNING THE TENDER FOR PRINTING AND SUPPLY OF VARIOUS TYPE OF ANSWER BOOKS/ OMR BAR CODE ANSWER BOOKS

1. Tenders for printing and supply of various type of answer sheets/OMR Bar code Answer Book are invited from the Offset Printers situated in the state of Punjab, having three years or more experience of OMR sheets printing of Govt. department/Board/Educational Institutes (please attach the photocopy of the purchase order) and having their own offset presses and having three years continues experience of printing to any state/Centre Govt institute during last five years.".The tenderer should have relevant experience of printing of Answer Book. Only Tenders received upto **01-12-2014** at **1.00pm** will be eligible for consideration as per Tender Notice and shall be further subject to the following terms and conditions.
2. Each tender should be accompanied with earnest money of Rs. 30000/- in form of Demand Draft in favour of the Secretary, Punjab State Board of Technical Education and Industrial Training, Chandigarh.Tender not accompanied with earnest money shall not be entertained. Earnest money in cash or by cheque shall not be accepted. No concession/exemption regarding deposit of earnest money will be given on any ground, what so ever and tenders not accompanied with earnest money will be rejected straightway.

Particulars of demand draft on account of earnest money must be filled in the Performa for Envelop No.1andthedemanddraft should be put in this envelope alongwith performa for "Technical details of the Press" in the tender document and other documents relating to qualifying conditions.

3. Tender should be filled in two separate parts and in two envelopes.EnvelopNo.1should contain the performa and all documents relating to qualifying conditions supplied along with this tender and may be subscribed on the envelope as" Envelop No. 1". Envelope No. 2will contain the Commercial Bid and rates should be quoted in the Performa supplied for this purpose along with this tender and may be subscribed as "**Envelop No. 2 - Commercial bid for printing and supply of Answer Books**".

EnvelopNo.1and 2 will be opened on dated **01-12-2014** at **3.00pm** in the presence of those tenderers who may wish to be present.The Commercial Bids of only those tenderers will be opened, who fulfilled all qualifying conditions. Officers of the Board may inspect the premises of the printers/suppliers in order to verify the particulars mentioned in Performa for EnvelopNo.1.In that case Commercial Bid will be opened on later date after analyzing the qualifying conditions.

4. Answer Books are to be supplied as per the specifications indicated in Schedule 'A'. If the supply is not in accordance with the specification indicated in schedule'A' (other than GSM), the whole or part of supply may be rejected by the Board and the firm is liable to take back the supply at his own cost and the amount of security money will be forfeited.
5. Rate should be quoted per Answer book in the Performa of "Commercial Bid" attached with Schedule 'A', which should be including printing, binding, sales tax, if any, other incidental charges including freight and octroi charges as may be applicable at any time during the execution of the order by the supplier.
6. The bidders will have to supply 3 identical samples of the papers along with their bids(A design/pattern of the Answer Books required by the Board can be seen in the Board's Office on any working day).Bid not accompanied by the samples shall not be entertained. The samples of papers with name of mill must be signed and stamped by the tenderer.
7. The bidders shall supply Answer Books exactly as per specifications indicated in Schedule 'A'. Any no. of sample of papers used for printing stationary may be drawn by the Board officials from the material at random and got tested from any laboratory of repute. Expense of laboratory charged will be borned by the Board incase material supplied is as per specification of GSM or within admissible tolerance limit as mentioned below. But in case

Note : Only one above said clause shall be applicable on one supply, depending upon delayed period of supply.

13. The responsibility to get the sample approved will solely lie with the party. Under no circumstances delay of more than 2 days will be credited. Any delay beyond two days will be counted towards delay on the part of supplier from the date of release of supply order with reference to clause 12.
14. The delivery of the Answer Books will be taken at the premises of the Board or place designated by the Board well in advance in the state of Punjab.
15. Supply order of tender quantity shall be given in one or more than one go as per the requirements of the Board.
16. The Board reserves the right to accept/reject the lowest tender or all the tenders without assigning any reason. It is not necessary that work will be allotted to all or any of the presses that participate in tender.
17. The tenderer should sign all the pages of the tender document and affix stamp.
18. In case a Printer surrenders the work after accepting the same, a penalty @25% will be imposed on the amount of surrendered work. If the supply is found short than what is mentioned in the invoice the Printer will have to make good the shortage within one week, otherwise failure would be taken as surrender of work and penalty will be imposed accordingly.
19. The details of infrastructure of the offset Printing Machines/computer facilities must be enclosed with the tender on the prescribed performa.
20. Printer is required to print the Answer Books at his own press and not allowed to distribute the work further to any other press. In case it is found that the printer is having the printing done from any other press, the Print Order will be cancelled and the printer will not be entitled for any payment. In such cases both the presses will be blacklisted and the security as well as earnest money will be forfeited.
21. All the disputes shall be subject to the jurisdiction of the Chandigarh Courts.
22. Tenderers responding to this enquiry shall be deemed to be agreeable to the terms and conditions herein contained. These terms and conditions shall be binding on the successful Tenderer. conditional Tenders are liable to be rejected.
23. 70% payment will be made within 20 days of receipt of original bill and balance after GSM testing.
24. Tenderer should not be black listed by any institution/Govt. Organisation.
25. Please attach performance certificate from atleast two educational institutions.
26. The tenderer should be from Punjab State only.
27. Vendor must have three year continuous experience of printing to any state/Centre Govt. institute during last five year.”

 - c) Three similar completed work costing not less than 15 lakhs

Note:- All the above mentioned answer books should be stitched instead of being stapled.

The size of bar coded OMR Theory answer books will be 8.5" x 12.0". The title page of these theory answer books will be a OMR barcoded sheet of size 8.0" x 14.0" / 8.5" x 14.0" and the detailed specifications for this OMR bar coded Title page will be as follows :

1. OMR Bar coded cover page of Bar coded OMR theory answer books will have three parts as per sample given.
2. These three / two parts should have smooth fine perforation, as per sample, between them. Each of these parts will have a bar code on it. These bar codes have to be unique Eight digit number and should not be repeated on any other bar coded OMR Theory Answer sheet and should be same for all the three / two parts of same bar coded OMR Theory Answer sheet.
3. The printing of Barcode should be done on laser printer. The printing should be sharp, straight, correct and of superior quality. Original and genuine toner should be used for printing of Barcodes. Make sure that refill toner is not used for printing of barcodes. Ink of the Barcode should not get removed while handling the sheets.
4. This Title page of Bar Coded OMR Theory Answer Book should be pasted as well as neatly stitched (**minimum 25 stitches**) with the internal pages.
5. The overall size of title page should be smaller than the size of the answer book. Title page should be stitched with the answer sheets in such a way so that the **size of the title page is lesser by 0.25 inch from top, bottom and right side.**
6. Paper of title page should be **110 GSM(Grade 'A') SS Map litho paper of 70-80% brightness.**

7. OMR bar coded cover page of Bar coded OMR theory answer books will use two colour printing.
8. The OMR sheets, colour of omr sheets, bar codes printed on it should be designed /printed so accurately so as to be properly read by NCS OPSCAN-8/FUJITSU FI-4750 or equivalent scanners. Firm should print total quantity of OMR Bar Code cover page in different colours such as red/orange/purple/green/blue supported for OMR scanner with pen reader.
9. All these OMR bar coded Title page should have exact cutting margin.
10. A test supply of OMR sheets/OMR bar coded Title page is to be done and approval for same is to be taken before printing full order.
11. The Answer books are required in the packing of 300 answer books in a bundle and to be packed in good quality card board packing after wrapping it with butter cover papers.
12. First part of Bar-Coded OMR answer book i.e. Part-A will have a running serial number(see sample). Each bundle will have label of unique name alongwith details of answer book starting serial number and ending serial number. Printer should supply a consolidated list of all these bundle names alongwith details. The printer should also supply a soft copy of the same. The packed answer books are to be delivered as per the instructions of the Board and within the time frame fixed by the Board.
13. The quantity can, however, be increased or decreased at the discretion of the Board. The manufacturer shall, however, not print a Answer Book more than the quantity ordered. If per chance excess answer books than the given order are printed accidentally, office is to be informed immediately and answer books be supplied to the office of the Board only with the undertaking that no such Answer Books are kept with the supplier. In case of any default/defect, the Chairman of the Board will be competent to take action as he may deem fit, which shall be final and binding on the manufacturer.

Order for the supply of Bar coded answer Books may be placed in one or more instalments during the period of validity of the tender and supply will have to be made within 30 days from the issue of supply order.
