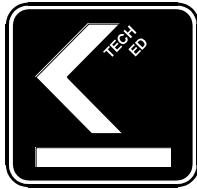

1. TENDER NOTICE

Sealed tenders are invited for disposal of following items:

Disposal of used Answer Sheets/ old Newspaper/magazines and other scrap paper.	Approx. 15 Lakh	Rs. 30,000/- (Rs Thirty thousand only) in form of Bank Draft drawn in favour of Secretary, Punjab State Board of Technical Education and Industrial Training payable at Chandigarh

The tender document can be obtained from 10.00 AM to 4.00 PM on all working days from the office of the Punjab State Board of Technical Education and Industrial Training, Plot 1A, Sector 36A, Chandigarh on payment of Rs. 500/- (Rupees Five hundred only), non-refundable, in cash, towards the cost of one tender document. Tender document can also be downloaded from the Board's website www.punjabteched.com and in such a case the bidder shall deposit the cost of tender documents along with submission of the tender, failing which his tender shall not be opened. The tender form complete in all respect should reach the office of the Board, at above mentioned address, in duly sealed envelope superscribed with "**Tender for disposal of Waste Paper**" up to 2.30 p.m on 09.08.2018. The tender will be opened on the same day at 3.30 p.m by a committee in presence of tenderer who may wish to be present. The Secretary Punjab State Board of Technical Education and Industrial Training reserves the right to accept or reject any or all the Tenders without assigning any reason. Incomplete & conditional tenders are liable to be rejected.

2. Tenderers must submit their bids in two separate envelopes. One envelope should contain technical bid and second envelope should contain financial bid. It must be noted that at first stage only the technical bids will be opened. And after the evaluation of technical bids, the financial bids will be opened only for the eligible bidders. The tenders of ineligible bidders shall be summarily rejected in the evaluation process and their financial bids will remain unopened.

Envelope-1 (Technical Bid)

The sealed envelope with "Tender for disposal of Waste Paper" clearly written on top of envelope, addressed to The Secretary, Punjab State Board of Technical Education and Industrial Training, Plot 1A, Sector 36A Chandigarh must reach the Board office up to 2.30 pm on 09.08.2018.

This envelope of technical bid must contain the following:

- I. Duly filled, signed & stamped tender document.
- II. Demand Draft/Pay Order of Rs. 500/- as cost of Tender Document (in case of downloaded document only).
- III. Demand Draft/Pay Order of Rs. 30,000/- (Thirty thousand only) drawn in favour of The Secretary, Punjab State Board of Technical Education and Industrial Training Payable at Chandigarh, as earnest money.
- IV. Self attested Copy of sale tax return along with audited balance sheets of last three years.
- V. Self attested copy of the PAN.
- VI. Self attested Documentary proof of registration of Sole Proprietorship/Partnership firm or Company must be attached.

Technical Bids shall be opened at 4:00 PM on the same day i.e. 09.08.2018 in the presence of the bidders or their authorized representatives intending to attend the opening. Any tender received later than the time and date of receipt of the bids shall be rejected.

Envelope-2 (Financial Bid)

The financial bids (Annexure 'A') will be opened at later stage only after evaluation process of technical bids.

3. Eligibility Criteria:

Only such bidders, who are Registered Sole Proprietor /Partnership firm or Company and meet the following conditions, can participate in the tender:

- A) Self attested Documentary proof of registration of Sole Proprietorship/Partnership firm or Company must be attached.
- B) The bidders must have a valid PAN to participate in the tender and must submit self attested copy of the same.

4. Terms & Conditions:

- 1. Sealed bids are invited for disposal of Waste Paper (used Answer sheets/old newspaper/magazines and other scrap paper) on as per where as basis. Bid should be sealed in a cover duly super scribed as Tender for disposal of Waste Paper.”
- 2. EMD of Rs. 30,000/- (Rupees Thirty Thousand Only) to be submitted along with the tender in the form of bank draft drawn in favour of The Secretary, Punjab State Board of Technical Education and Industrial Training Payable at Chandigarh.
- 3. The bidders should quote their highest rates based upon the Terms and Conditions forming part of tender document. Order will be placed to the successful bidder (quoting highest rates of purchase) out of the eligible bidders.
- 4. In case, the date of submission/opening of tenders happens to be holiday, the tenders shall be received/opened on the next working day.
- 5. The Earnest Money Deposit (EMD) of bidders, whose rates are not approved, will be returned within 30 days upon finalization of the tenders. No interest will be paid on the amount of the security deposit. However, the EMD of the bidder, whose rates are accepted, will be returned on submission of performance undertaking after completion of the entire job that the material has been received by them in full quantity, mentioning the weight of the material. Only then the EMD will be released and adjustment of final account will be made.
- 6. The right to accept a bid will rest with the Secretary, Punjab State Board of Technical Education and Industrial Training, who reserve the right to reject any or all the bids without assigning any reason thereof.
- 7. The quoted rates should be valid for one year from the date of acceptance.
- 8. In case, the vendor fails to comply the terms & conditions, the Board may terminate the contract without assigning any reason and is free to dispose of the waste paper items in such a manner as may be deemed appropriate.
- 9. The successful bidder will be liable to complete the job of lifting the material from the Board office within a period of 12 days of getting the order. If the successful bidder does not start work in time or stops the work midway or leaves the work altogether, his EMD will be forfeited and the Board shall have the right to cancel the order.
- 10. It will be responsibility of the vendor to pack the material by his own labourers and the cost towards transportation, packing, loading, unloading etc. will also be borne by the vendor himself.

11. It will be responsibility of the vendor that the waste paper being lifted from the Board will be used only for recycling in paper mill or in pulp industry or will be destroyed in an appropriate manner to ensure official secrecy.
12. Bidders may visit the Board premises and inspect the quantity, condition and type of material being sold.
13. The weighing of the material shall be jointly witnessed by a committee of the Board's authorized representative(s) and bidder or his authorized representative. All weighing shall be certified by this weighing committee. The weighing site for this purpose will be jointly decided by the successful bidder and the Board.
14. The successful bidder shall have to deposit an amount equivalent to 1.25 times the total estimated cost of the materials planned to be lifted in one phase in the form of DD/cash. The DD should be drawn in favour of the Secretary, Punjab State Board of Technical Education and Industrial Training, payable at Chandigarh. In case, the successful bidder does not deposit the requisite money, Earnest Money Deposit shall be forfeited and order shall be cancelled.
Each Page of the Tender document should be signed by the tenderer.
